Information Sheet

Introduction

Decommissioning of small facilities was not systematically addressed at an international level in the past. The IAEA launched the International Project on Decommissioning of Medical, Industrial and Research Facilities (MIRDEC) at the 1st TM held in June 2018, when the relevant experiences from MS were presented and discussed, and the needs for assistance and cooperation analysed. In 2019 one meeting of the MIRDEC Coordination Group was held. The 2nd TM was held in February 2020, which included parallel sessions of the 5 Working Groups and 1-day workshop on characterization for decommissioning purposes. This TM is the third Annual Meeting of the project, and will focus on preparation of case studies on decommissioning of different types of small facilities that are of primary interest to the MS.

Objectives

To further review and discuss Member States' experiences with the decommissioning of small medical, industrial and research facilities, and to continue the development of case studies for selected types of small facilities.

Target Audience

The project is open to those IAEA Member States, preferred are participants who attended the first two Technical Meetings of the MIRDEC project (June 2018 and February 2020). The candidates to be nominated should be professionals from national authorities, policy making organizations, regulatory bodies, decommissioning licensee organizations, technical support organizations and service providers that are or will be involved in the planning, implementation or regulatory control of decommissioning of medical, industrial and research facilities.

Working Language(s)

English

Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State, participants are requested to send the **Participation** Form (Form A) to their competent national authority (e.g. Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) for onward transmission to the IAEA by **28 April 2021**. Participants who are members of an organization invited to attend are requested to send the **Participation Form (Form A)** through their organization to the IAEA by above deadline.

Selected participants will be informed in due course on the procedures to be followed with regard to administrative and financial matters.

Expenditures and Grants

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made using the **Grant Application Form (Form C)** which has to be stamped, signed and submitted by the competent national authority to the IAEA together with the **Participation Form (Form A)** by **15 March 2021**.

Venue

The event will be held at the Vienna International Centre (VIC) where the IAEA's Headquarters are located. Participants must make their own travel and accommodation arrangements.

General information on the VIC and other practical details, such as a list of hotels offering a reduced rate for IAEA participants, are listed on the following IAEA web page: http://www-pub.iaea.org/iaeaevents/GeneralInfo/Guide/VIC.

Participants are advised to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day in order to allow for timely registration. Participants will need to present an official photo identification document in order to be admitted to the VIC premises.

Visas

Participants who require a visa to enter Austria should submit the necessary application to the nearest diplomatic or consular representative of Austria at least four weeks before they travel to Austria. Since Austria is a Schengen State, persons requiring a visa will have to apply for a Schengen visa. In States where Austria has no diplomatic mission, visas can be obtained from the consular authority of a Schengen Partner State representing Austria in the country in question.
